ASSIGNMENT

Whereas Zi Technology Corporation Limited, having a principal place of business at Clarendon House, 2 Church Street, P.O. Box HM 666, Hamilton HM CX, Bermuda, hereinafter called "Assignor," is the owner of certain inventions or discoveries (or both), of Letters Patent of the United States of America entitled TEXT INPUT SYSTEM FOR IDEOGRAPHIC AND NONIDEOGRAPHIC LANGUAGES, U.S. Patent No. 6,801,659, the specification of which was filed on June 4, 2001, and accorded Serial Number 09/857,363, which issued on October 5, 2004; and

Whereas Zi Corporation of Canada, Inc., having a principal place of business at Suite 2100, 840 – 7 Avenue S.W., Calgary, Alberta T2P 3G2, CANADA, and which, together with its successors and assigns, is hereinafter called "Assignee," is desirous of acquiring the title, rights, benefits, and privileges hereinafter recited;

Now, Therefore, for valuable consideration furnished by Assignee to Assignor, receipt and sufficiency of which is hereby acknowledged, Assignor hereby, without reservation:

1. Assigns, transfers, and conveys to Assignee its entire right, title, and interest in and to said inventions and discoveries, said Letters Patent of the United States of America, any and all other applications for Letters Patent on said inventions and discoveries in whatsoever countries, including all divisional, renewal, substitute, continuation, continuation-in-part, and Convention applications based in whole or in part upon said inventions or discoveries, or upon said applications, and any and all Letters Patent, reissues, reexaminations, and extensions of Letters Patent granted for said inventions and discoveries or upon said applications, and every priority right that is or may be predicated upon or arise from said inventions, said discoveries, said applications, and said Letters Patent;

2. Authorize Assignee to file patent applications in any or all countries on any or all of said inventions and discoveries in its name or in the name of Assignee or otherwise as Assignee may deem advisable, under the International Convention or otherwise;


3. Authorize and request the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of all other governments to issue or transfer all said Letters Patent to Assignee, as assignee of the entire right, title, and interest therein or otherwise as Assignee may direct;

4. Warrant that Assignor has not knowingly conveyed to others any right in said inventions, discoveries, applications, or patents or any license to use the same or to make, use, or sell anything embodying or utilizing any of said inventions or discoveries; and that Assignor has good right to assign the same to Assignee without encumbrance;

5. Bind its heirs, legal representatives and assigns, as well as itself, to do, upon Assignee's request and at Assignee's expense, but without additional consideration to it or them, all acts reasonably serving to assure that the said inventions and discoveries and the said Letters Patent shall be held and enjoyed by Assignee as fully and entirely as the same could have been held and enjoyed by Assignor, its heirs, legal representatives, and assigns if this assignment had not been made; and particularly to execute and deliver


