I hereby authorize and request the Director of the United States Patent and Trademark Office to issue any Letters Patent which may be granted for said invention or upon said application to said assignee, its successors and assigns, in accordance with this assignment.

I hereby authorize said assignee to apply for patents on said invention in foreign countries, claiming the filing date of said application under the provisions of the Paris Convention for the Protection of

Industrial Property and all other applicable treaties and laws, and I further agree to execute any and all documents that may be required or desired by said assignee in order that said assignee may apply for Letters Patent on said invention in foreign countries in my or its name.

I hereby agree to promptly communicate to said assignee or its representatives any facts known to me respecting said invention or said application; to testify in any legal proceeding relating thereto; to sign all lawful papers, including but not limited to all divisional, continuing, continuing in part, reissue, substitute, and extension applications, all rightful oaths or declarations, and documents confirming or substituting for this assignment.

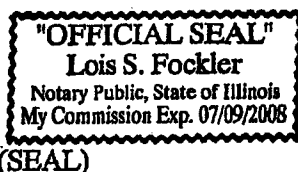


