**ASSIGNMENT OF INVENTION AND OF LETTERS PATENT**

WHEREAS, I, **ROY D. P. FODEN**, residing at 48 Coppice Walk, Denton, Manchester United Kingdom, M34 2DE, am a citizen of United Kingdom and have invented certain new and useful inventions or improvements relating to shipping and display container for which I have executed an application for Letters Patent of the United States of America, entitled "**SHIPPING AND DISPLAY CONTAINER**" filed on **July 11, 2007** and having been afforded serial no. **11/827,161**, by the United States Patent and Trademark Office; and

AND, I HEREBY authorize and request the Commissioner of Patents and Trademarks of the United States, and any official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said inventions or improvements to the said Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument;

AND, I HEREBY covenant that I have full right to convey the entire right, title and interest herein assigned, and that I have not executed and will not execute, any agreement in conflict herewith;

AND, I HEREBY authorize and request the attorney of record in the said application for Letters Patent to insert in the above right hand corner of this Assignment the serial number and filing date of the said application when officially known;

AND, I HEREBY further covenant and agree that I will communicate to the said Assignee, its successors, legal representatives and assigns, any and all facts known to me respecting said inventions or improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, reissue, continuation, and continuation-in-part applications, make all rightful oaths and generally do everything possible to aid the said Assignee, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said inventions or improvements in all countries.
