The undersigned hereby certifies that:

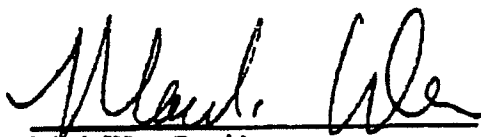
1. He is the duly elected and acting President of Avatar Incorporated Vascular Architects, a Delaware corporation.
