US Patent and the invention therein contained, including all rights of action and damages for past infringement, and including the right to apply for any Letters Patent in the United States of America on said invention and including the right to claim the priority of the date of filing in the United States and any Letters Patent that may issue thereon, or therefor, in the United States and all reissues, extensions, renewals, divisions and continuations thereof, to the full end of the term or terms for which said Letters Patent may be issued, to be held and enjoyed by the said RIKEN and MegaOpto Co., Ltd., its successors and assigns the same as it would have been held and enjoyed by NEC TOKIN Corporation, if this assignment and sale had not been made.

NEC TOKIN Corporation, hereby represents and warrants that there are no rights or interests outstanding inconsistent with the rights and interests granted herein and that NEC TOKIN Corporation, will not execute any instrument or grant or transfer any rights or interests inconsistent therewith, and NEC TOKIN Corporation, binds itself and its heirs, executors, administrators, employees and legal representatives, as the case may be, to execute and deliver to the said RIKEN and MegaOpto Co., Ltd., its successors and assigns, any further documents or instruments and do any and all further acts that may be deemed necessary by the said RIKEN and MegaOpto Co., Ltd., its successors and assigns to vest in the said RIKEN and MegaOpto Co., Ltd., its successors and assigns, the title herein conveyed, or intended so to be, and to enable such title to be recorded in the United States.

AND, NEC TOKIN Corporation, further covenants and agrees, in consideration of the premises, that it, its executors and administrators will, at any time upon request, communicate to the said RIKEN and MegaOpto Co., Ltd., its successors and assigns, any facts relating to the said invention and improvements and the history thereof, known to it or its successors and assigns, and that it will testify as to the same in any interference or other proceeding when requested to do so by the said RIKEN and MegaOpto Co., Ltd., its successors and assigns.

The undersigned hereby grants the law firm of Birch, Stewart, Kolasch & Birch, LLP the power to insert on this Assignment any further identification that may be necessary or desirable

in order to comply with the rules of the U.S. Patent and Trademark Office for recordation of this document.
