**GRANT OF SECURITY INTEREST IN  
U.S. PATENTS AND REGISTERED TRADEMARK**


WHEREAS, TIETEK, LLC, a Delaware limited liability company, with offices located at 429 Memory Lane, Marshall, Texas 75672 ("Grantor"); and OPUS 5949, LLC f/k/a TIE INVESTORS, LLC, a Texas limited liability company, with offices located at 5949 Sherry Lane, Suite 1900, Dallas, Texas 75225 ("Grantee"), are parties to (i) a certain Security Agreement, dated February 5, 2004 (the "Security Agreement"), and (ii) a certain Patent Security Agreement, dated February 5, 2004 (the "Patent Security Agreement"), which are incorporated herein by reference;

WHEREAS, the Security Agreement and the Patent Security Agreement provide, *inter alia*, for the granting of a lien on, and a security interest in (i) U.S. Patent No. 5,886,078 (the "'078 Patent") issued on March 23, 1999, (ii) U.S. Patent Published Application No. 20020123553 applied for on March 5, 2001, now U.S. Patent No. 6,828,372 issued on December 7, 2004 (the "'372 Patent"), and (iii) the trademark TIETEK, now the subject of U.S. Registration No. 3,188,514 (the "Trademark"); and

WHEREAS, it is the purpose of this document to perfect and memorialize the security interest granted to Grantee in the '078 Patent, the '372 Patent and the Trademark, in a form suitable for recording in the United States Patent and Trademark Office.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is acknowledged, and subject to the terms and conditions of the Agreement, Grantor hereby grants to Grantee, its successors and assigns, a perfected first priority continuing general security interest in and lien on (i) the '078 and '372 Patents including, without limitation, all divisions, reissues, substitutions, continuations, continuations-in-part, renewals, and extensions thereof, (ii) the Trademark and the goodwill of the business in which the Mark is used; together with (a) all income, royalties, damages, and payments for past or future infringements of any of the foregoing; (b) the right to sue for past, present, and future infringements of any of the foregoing; (c) all rights corresponding thereto; (d) all accounts receivable, general intangibles, and instruments arising out of any of the foregoing; (e) all proceeds of insurance relating to any of the foregoing; and (f) all proceeds of any of the foregoing, to secure the Obligations (as defined in the Security Agreement). Grantor further agrees that it will pay any maintenance fees and do all other things necessary to maintain the '078 and '372 Patents and the Trademark in force during the term of this grant of security interest.
