(iii) the goodwill of the business symbolized by the Patents and (iv) all causes of action arising prior to or after July 3, 1999 for infringement of any of the Patents or unfair competition regarding the same, and granted to the Agent by the Assignor by the Security Agreement, which Assignment was duly recorded on December 31, 1997 at Patent Reel 8907, Frame 0317 in the United States Patent and Trademark Office.


