**PATENT RELEASE AND REASSIGNMENT**

THIS PATENT RELEASE AND REASSIGNMENT is made as of August 22, 2007, by **ALLIED CAPITAL CORPORATION** (“Allied”).

W I T N E S S E T H:

WHEREAS, Allied and Woodstream Corporation (formerly known as Perky-Pet Products Co.), a Pennsylvania corporation (“**Grantor**”), were parties to that certain Patent Security Agreement, dated as August 19, 2005 (the “**Assignment**”), pursuant to which Grantor granted a security interest to Allied in certain patents (the “**Patents**”) and Patent Rights (as defined below) as security for certain obligations owing by Grantor to Allied, including the Patents set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Patent Division of the United States Patent and Trademark Office on June 26, 2006, at Reel 018026, Frame 0350; and

WHEREAS, Grantor has requested that Allied release its security interest in the Patents and Patent Rights and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Allied hereby releases its security interest in all of Grantor’s right, title and interest in and to the following (collectively the “**Patent Rights**”):

(i) each Patent and application for Patent listed on Schedule I annexed hereto, together with any reissues, continuations or extensions thereof; and


(ii) all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future infringement of any Patent.

2. Allied hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Allied, all of Allied’s right, title and interest in and to the Patents and the Patent Rights.
