Assignment of Intellectual Property
(Asset Purchase Agreement §2.06(d))

Assignor does hereby warrant and defend the title to the Intellectual Property against the lawful claims and demands of all persons. Assignor shall execute such documents and use commercially reasonable efforts to take or cause to be taken all actions and to do or cause to be done all things necessary, proper or advisable to consummate the transactions contemplated by this Assignment (including, without limitation, to put Assignee in actual possession and operating control of the Intellectual Property, to effectuate, record or perfect the transfer of the Intellectual Property to Assignee, to confirm

the title of the Intellectual Property in Assignee and to assist Assignee in exercising rights relating thereto), and to make all filings and give all notices which may be necessary or required in order to effectuate the transactions contemplated hereby.
