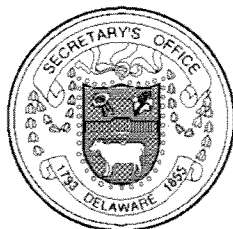

FIRST: The name of the corporation is **VERITAS OPERATING CORPORATION** (formerly Veritas Software Corporation) and the date of filing the original Certificate of Incorporation of this company with the Secretary of State of the State of Delaware was January 6, 1997.
