Assignor further covenants and agrees that when requested by the Assignee, and without further consideration, but at the cost and expense of the Assignee, Assignor will, for any and all countries, execute and deliver all applications for patent on said improvements, execute all lawful oaths and other papers, supply to the Assignee all facts and evidence known to us relating to said improvements and the history and development thereof, testify in all interferences, suits, and other legal proceedings, and generally do everything rightful which the Assignee shall consider desirable for aiding in securing, maintaining, and enforcing proper patent protection for said improvements and for vesting the title to said improvements in the Assignee.

The Assignor further covenants that it has the lawful right to assign the interest in said improvements in the manner and form as herein expressed, that the interests herein conveyed are free from prior assignment, grant, mortgage, license, or other encumbrance whatsoever and that the execution of this Assignment is its own free act and deed.

The Assignor further represents that the person signing this Assignment on behalf of Assignor is authorized to do so.
