

ASSIGNMENT OF INVENTIONS, PATENT APPLICATIONS AND PATENTS

and

CARTIER CREATION STUDIO S.A., a company organized and existing under the laws of Switzerland and having its address at 8, boulevard James-Fazy, Genève, Switzerland (hereinafter referred to as "the Assignee").

PREAMBLE

WHEREAS the Assignor is the owner of inventions, know-how, pending patent applications, and granted patents (hereinafter referred to as "the Intellectual Property Rights").

The above right, title and interest includes the right to all divisions and continuations of the Patents, to all reissues and extensions of the Patents that may be granted, to all rights of priority based on the Patents granted by local laws and treaties including any international convention for the protection of industrial property, and all extensions of the Patents in any country or countries including all renewals, reissues and any further extensions thereof.

2. The Assignor hereby assigns, transfers and conveys to the Assignee all rights to institute or maintain legal proceedings, or to secure legal and/or administrative relief including damages, in respect of any infringement of, or other unauthorised use in relation to the Intellectual Property Rights which may have arisen or accrued prior to the effective date of this Assignment.
3. The Assignor appoints and constitutes the Assignee as its attorney-in-fact, with full power of substitution, for and on behalf of such Assignor in relation to any purpose or action necessary or appropriate to effectuate and/or confirm the Assignment herein.
