ASSIGNMENT

WHEREAS, I, Klaus F. Schuegraf, residing at 26 Groveside Dr., Aliso Viejo, CA 92656, have invented certain new and useful improvements disclosed in an application for United States Letters Patent titled Method for Controlling Critical Dimension in a Polycrystalline Silicon Emitter and Related Structure, filed herewith;

AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith;

AND I HEREBY further covenant and agree that I will communicate to Assignee any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, continuations-in-part, substitute and reissue applications, make all rightful oaths, and generally do everything possible to aid Assignee to obtain and enforce proper patent protection for said improvements in all countries.
