**TERMINATION AND RELEASE OF  
PATENT COLLATERAL ASSIGNMENT AND SECURITY AGREEMENT  
(US Patent Assignment Wabash Alloys, L.L.C.)**

**TERMINATION AND RELEASE OF PATENT COLLATERAL ASSIGNMENT AND SECURITY AGREEMENT**, dated as September 11, 2007 by **BANK OF AMERICA, N.A.** (as assignee of Fleet Capital Corporation), in its capacity as Agent (the "Agent") in connection with the Revolving Credit Agreement, dated as of October 30, 2001 (as amended and restated pursuant to that certain Amended and Restated Revolving Credit Agreement dated as of December 19, 2005 and that certain Second Amended and Restated Revolving Credit Agreement dated as of February 12, 2007 and as it may be further amended and in effect from time to time, the "Credit Agreement") by and among Wabash Alloys, L.L.C. (as successor by merger to Wabash Aluminum Alloys, L.L.C.), a Delaware limited liability company (the "Assignor"), Connell Limited Partnership, a Delaware limited Partnership ("CLP"), and Connell Industries Canada Company, a Nova Scotia Company ("Connell Canada" and together with the Assignor and CLP, collectively the "Borrowers"), the lenders party thereto, the Agent and Bank of America, N.A. (as successor by merger to Fleet National Bank), as Issuing Bank.

**WHEREAS**, the Assignor and the Agent entered into that certain Patent Collateral Assignment and Security Agreement dated as of October 30, 2001 (the "Patent Assignment") which Patent Assignment was recorded with the United States Patent and Trademark Office at Reel 012418 Frame 0808 on October 30, 2001 for the purpose of securing payment and performance of the Obligations (as defined in the Credit Agreement) of the Borrowers;


**WHEREAS**, pursuant to the Security Agreement (as defined in the Patent Assignment) the Assignor granted, assigned, transferred and conveyed to the Agent, for the benefit of the Lenders and the Agent, by way of collateral security, all of the Patent Collateral as security for the Obligations;

**WHEREAS**, the Agent has agreed to terminate and release the Patent Collateral and assign and transfer to the Assignor all deeds, assignments and other instruments as may be necessary or proper to reassign and reconvey to re-vest in the Assignor the entire right, title and interest to the Patent Collateral as herein provided;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates and releases the Patent Assignment and assigns and transfers to the Assignor, without representation, warranty or recourse, all of the Agent's right, title and interest in and to the Patent Collateral, including, without limitation, the patents listed on Exhibit A attached hereto, effective as of the date set forth above.
