ASSIGNMENT

KG**, its successors and assigns, all the same as I would have held and enjoyed had this Assignment not been made.

I hereby request and authorize the Commissioner of Patents and Trademarks of the United States of America to grant, issue and transfer any letters patent for said invention to **Pöppelmann Holding GmbH & Co. KG** as assignee of the entire right, title and interest therein, in accordance with this instrument of assignment.
