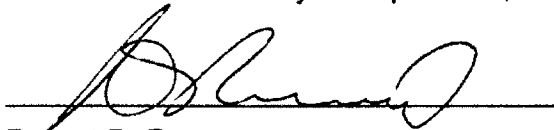
ASSIGNMENT OF PATENT
