

ASSIGNMENT

WHEREAS, James Jackson, a citizen of the United States of America, residing at 6109 Anemone CV, Austin, TX 78759, U.S.A.; Mehrad Yasrebi, a citizen of Canada, residing at 10624 Chestnut RidgeRd, Austin, TX 78726, U.S.A.; hereinafter called the "Assignors", have made the invention described in the United States patent application entitled "METHODS AND APPARATUS TO ROUTE EMERGENCY COMMUNICATION SESSIONS", Attorney Docket No. 20103/2007-0032, for a full description of which reference is here made to an application for Letters Patent of the United States filed on 9/14/2007 and assigned Application Serial No. 11/855,837 ; and

Assignors authorize attorney or agent to fill in the U.S. Application Serial No. above, if required.

AND said Assignors authorize and request the Commissioner of Patents to issue Letters Patent on said application, and on any all divisions and continuations thereof, to

said Assignee, its assigns and legal representatives, in accordance with the terms of this Assignment.


