We hereby further agree that we will communicate to ASSIGNEE, or to its successors, assigns, and legal representatives, any facts known to us respecting any improvements; and, at the expense of ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue, and substitute applications, make all lawful oaths, and generally do everything possible to vest title in ASSIGNEE and to aid ASSIGNEE, its successors, assigns, and legal representatives to obtain and enforce proper protection for said invention in all countries.
