## ASSIGNMENT AGREEMENT

For good and valuable consideration, the receipt of which is hereby acknowledged, I, **Eric A. I hereby authorize and request the Assistant Commissioner of Patents of the United States of America to issue Letters Patent upon the aforesaid application, division, extension, continuation or reissue, to **Eric A. Seibold** and **Royce Eric Curtin** for our joint use and benefit, our successors, assigns and legal representatives, to the full end of the term for which said Letters Patent may be granted, the same as they would have been held and enjoyed by me had

this assignment not been made, and I hereby authorize and request the equivalent authorities in foreign countries to issue the patents of their respective countries to **Eric A. Seibold and Royce Eric Curtin**.

I agree that, when requested, I will, without charge to said **Royce Eric Curtin**, but at his expense, sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable or convenient for securing and maintaining patents for said inventions in all countries and for vesting fifty percent (50%) title thereto in said **Royce Eric Curtin**, his successors, assigns and legal representatives or nominees.

I covenant with said **Royce Eric Curtin**, his successors, assigns and legal representatives, that the interest and property hereby conveyed is free from all prior assignment, grant, mortgage, license or other encumbrance.
