ASSIGNMENT

WHEREAS, we, **Hans-Peter WILD**, a citizen of Germany, c/o Indag Gesellschaft Fur Industriebedarf MBH & Co., Betriebs KG, Rudolf-Wild-Strasse 107-115, 69214 Eppelheim, Germany; **Eberhard KRAFT**, a citizen of Germany, residing at Hebelstrasse 1, 74924 Neckarbischofsheim, Germany, and **Frank LECHERT**, a citizen of Germany, residing at Am Pilgerhaus 7, 69469 Weinheim Germany, hereinafter referred to as **ASSIGNORS**, have invented certain new and useful improvements in **GRIPPER DEVICE** for which we have respectively executed an application for Letters Patents of the United States which was filed with the United States Patent and Trademark Office on **July 24, 2007**, and which has been accorded Application Serial No. **11/782,500**.

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) to us in hand paid, and other good and valuable consideration, the receipt of which is hereby acknowledged, we, the **ASSIGNORS**, has sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, unto the **ASSIGNEE**, its successors, legal representatives and assigns, the entire right, title and interest in, to and under the improvements, and the application and all divisions, renewals and continuations thereof, and all Letters Patent of the United States which may be granted thereon and all reissues and extensions thereof, and all applications for Letters Patent which may hereafter be filed for the improvements in any country or countries foreign to the United States, and all Letters Patent which may be granted for the improvements in any country or countries foreign to the United States and all extensions, renewals and reissues thereof; and we hereby authorize and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for the improvements to the **ASSIGNEE**, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND WE HEREBY grant to Lawrence Rosenthal, Steven B. Pokotilow, Matthew W. Siegal, David L. Schaeffer, Ian G. DiBernardo, Charles E. Cantino, Angie Hankins and Brian M. Rothcry, attorneys with the firm of Stroock & Stroock & Lavan LLP, the right and full power of attorney to enter all further identifying information of the improvements and the application as may be deemed necessary or desirable for the recordation or perfection of this ASSIGNMENT.

AND WE HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith.






