4. Warrant that I have not conveyed to others any right, title, or interest in said inventions, discoveries, applications, or patents or any license to use the same or to make, use or sell anything embodying or utilizing any said inventions or discoveries; that I have good right to assign the same to Assignee without encumbrance; and that we are aware of no claim to the contrary.
