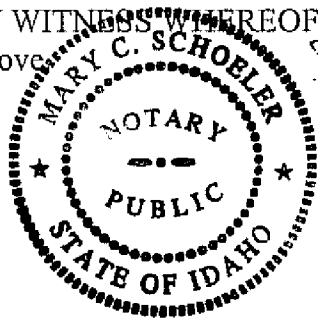

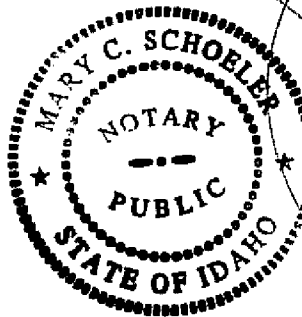

SUBJECT: Status Report of Restructuring and Asset Transfer

As President of Stellar Technologies and as authorized representative of iTerra Communications LLC, I acknowledge that Stellar Technologies, as the controlling voting member of iTerra Communications LLC, and iTerra Communications, as the controlling member of GigOptix LLC, have respectively approved the transfer of all of the assets of iTerra Communications LLC to GigOptix LLC, in exchange for iTerra Communications receiving 54% of the authorized equity in GigOptix. Additionally, GigOptix has assumed all liabilities of iTerra Communications LLC excluding the outstanding loans from Stellar Technologies to iTerra Communications. Stellar Technologies will look only to iTerra Communications for the repayment of those loans outstanding.
