This Assignment is made by Jesse A. Assignor hereby requests that said Letters Patent be issued in accordance with this Assignment.

Assignor further warrants and represents that, at the time of the execution and delivery of these presents, Assignor possesses his full title to the invention and application above-mentioned, and that he has the unencumbered right and authority to make this assignment.

Assignor further covenants and agrees, and likewise binds his heirs, legal representatives and assigns, to promptly communicate to said Assignee or his representatives any facts known to him relating to said invention, to testify in any interference or legal proceedings involving said invention, to execute any additional papers which may be requested to confirm the right of the Assignee, his representatives, successors and assigns to secure patent or similar protection for said invention in all countries and to vest in the Assignee complete title to the invention and Letters Patent, without further compensation, but at the expense of said Assignee, his successors, assigns and other legal representatives.


