PATENT ASSIGNMENT

and any and all Letters Patent of the United States and throughout the world which may be granted therefore, and any and all reissues of said Letters Patent, the same to be held and enjoyed by ASSIGNEE, its legal representatives, successors and assigns, to the full end of the term for which said Letters Patent may be granted or may be reissued or extended.
