ASSIGNMENT


For good and valuable consideration, the receipt of which is hereby acknowledged, we, John J. Lazzeroni and Melinda K. Carevich, hereby assign and transfer to J&M Corporation, a corporation of the State of Arizona, having its principal offices at 1415 S. We hereby authorize and request the Commissioner of Patents of the United States of America to issue Letters Patent upon the aforesaid application, division, extension, continuation, continuation-in-part or reissue, to J&M Corporation for the sole use and benefit of said J&M Corporation, its successors, assigns and legal representatives, to the full end of the term for which said Letters Patent may be granted, the same as they would have been held and enjoyed by us had this assignment not been made, and we hereby authorize and request the equivalent authorities in foreign countries to issue the patents of their respective countries to said J&M Corporation.

We agree that, when requested, we will, without charge to said J&M Corporation, but at its expense, sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable or convenient for securing and/or maintaining patents for said invention in any and all countries and for vesting title thereto in said J&M Corporation, its successors, assigns and legal representatives or nominees.


