

AND PERIC hereby authorizes and grants to the firm RIDOUT & MAYBEE LLP of One City Centre Drive, Suite 308, Mississauga, Ontario, L5B 1M2, Canada, the power to insert on this Assignment such further identification which may be necessary or desirable in order to comply with the patent regulations of any country for recordation of this document.


