METHODS FOR WRITING AND READING HIGHLY RESOLVED DOMAINS FOR HIGH DENSITY DATA STORAGE

and have executed a declaration or oath for an application for a United States patent disclosing and identifying the invention, said invention having been filed on the 3rd day of December 2004, and assigned U.S. Patent Application No. 11/004,153, which claims priority to U.S. Provisional Patent Application No. 60/563,123, filed April 16, 2004.


