SENIOR PATENT SECURITY AGREEMENT

This SENIOR PATENT SECURITY AGREEMENT ("Agreement"), dated as of October 11, 2007, is entered into by and between Websense, Inc. and PortAuthority Technologies, Inc. (collectively, the "Grantors") and Morgan Stanley & Co. Incorporated, as Senior Collateral Agent (the "Senior Collateral Agent") pursuant to that certain Senior Guarantee and Collateral Agreement dated as of October 11, 2007, between the Senior Collateral Agent and each of the Grantors (the "Security Agreement"), and pursuant to that certain Senior Credit Agreement, dated as of October 11, 2007 (as amended, amended and restated, supplemented, restated, replaced, refinanced or otherwise modified from time to time, the "Credit Agreement") among Websense, a Delaware corporation (the "Borrower"), the several banks and other financial institutions or entities from time to time parties thereto, Morgan Stanley Senior Funding, Inc., as sole lead arranger and sole bookrunner, Bank of America, N.A., as syndication agent, the co-documentation agents named therein, Morgan Stanley Senior Funding, Inc., as senior administrative agent, and the Senior Collateral Agent.

Capitalized terms not otherwise defined herein have the respective meanings ascribed to them in the Security Agreement or the Credit Agreement, as applicable.

WHEREAS, pursuant to the Security Agreement, each Grantor is granting a security interest to the Senior Collateral Agent in certain Collateral, including the Patents set forth on Schedule A hereto.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, each of the Grantors and the Senior Collateral Agent hereby agree as follows:

1. Grant of Security Interest

(a) Each Grantor hereby grants to the Senior Collateral Agent, for the benefit of the Senior Secured Parties, a security interest in all Patents now owned or at any time hereafter acquired by such Grantor or in which such Grantor now has or at any time in the future may acquire any right, title or interest, as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of all of the Senior Obligations.

(b) Schedule A hereto contains a true and accurate list of all of each Grantor's United States Patents, including all patent applications, as of the date hereof.

(c) The security interest granted hereby is granted in conjunction with the security interest granted to the Senior Collateral Agent under the Security Agreement. The rights and remedies of the Senior Collateral Agent with respect to the security interest granted hereby are in addition to those set forth in the Security Agreement (which is deemed incorporated by reference herein) and those which are now or hereafter available to the Senior Collateral Agent as a matter of law or equity. The

exercise by the Senior Collateral Agent of any one or more of the rights, powers or remedies provided for in this Agreement, in the Security Agreement, or now or hereafter existing at law or in equity shall not preclude the simultaneous or later exercise by any person, including the Senior Collateral Agent, of any or all other rights, powers or remedies.

2. Modifications

This Agreement or any provision hereof may not be changed, waived, or terminated except in accordance with the amendment provisions of the Security Agreement. Notwithstanding the foregoing, each Grantor authorizes the Senior Collateral Agent, upon notice to such Grantor, to modify this Agreement in the name of and on behalf of such Grantor without obtaining such Grantor's signature to such modification, to the extent that such modification constitutes an amendment of Schedule A, to add any right, title or interest in any Patent owned or subsequently acquired by such Grantor. Each Grantor additionally agrees to execute any additional agreement or amendment hereto as may be reasonably required by the Senior Collateral Agent from time to time, to subject any such owned or subsequently acquired right, title or interest in any Patent to the liens and perfection created or contemplated hereby or by the Security Agreement.

3. Governing Law

THIS AGREEMENT AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.

4. Successors and Assigns

This Agreement shall be binding upon the successors and assigns of each Grantor and shall inure to the benefit of the Senior Secured Parties and their successors and assigns; provided that no Grantor may assign, transfer or delegate any of its rights or obligations under this Agreement without the prior written consent of the Senior Collateral Agent (other than as provided in Section 11.6 of the Credit Agreement) and, unless so consented to, each such assignment, transfer or delegation by any Grantor shall be void.

5. Counterparts


This Agreement may be executed by one or more of the parties to this Agreement on any number of separate counterparts, and all of said counterparties taken together shall be deemed to constitute one and the same instrument. Delivery of an executed signature page of this Agreement by facsimile transmission shall be effective as delivery of a manually executed counterpart hereof. A set of the copies of this Agreement signed by all the parties shall be lodged with the Borrower, the Administrative Agent and the Senior Collateral Agent.


