AND, Assignor further covenants and agrees that Assignor will, without further consideration, communicate with Assignee, its successors and assigns, any facts known to Assignor respecting the inventions and testify in any legal proceeding, sign all lawful papers when called upon to do so, execute and deliver all papers that may be necessary or desirable to perfect the title to the inventions in said Assignee, its successors and assigns, execute all divisional, continuation, and reissue applications, make all rightful oaths and generally do everything possible to aid Assignee, its successors and assigns, to obtain and enforce proper patent protection for the inventions in the United States, it being understood that any expense incident to the execution of such papers shall be borne by Assignee, its successors and assigns;

AND, no provision in this Assignment shall restrict or limit in any way the rights, entitlements, and benefits of Assignee provided under any agreement between Assignor and Assignee relating to the patent and patent applications listed in Schedule A.
