WHEREAS, Columbia Machine, Inc. a corporation organized under the laws of the State of Washington, having a place of business at 107 Grand Blvd., Vancouver, Washington 98661, entered into a contract with Westblock Systems, Inc., a corporation organized under the laws of the State of Oregon, having a place of business at 1740 NE Lombard Drive, Portland, Oregon 97211, to develop a mold for manufacturing retaining blocks; and

WHEREAS, I, Llewellyn Lee Johnston, of 11108 NE 26th Avenue, Vancouver, Washington 98686, am an employee of Columbia Machine, Inc. and have developed, pursuant to said contract and in collaboration with James Hammer of Westblock Systems, Inc., an invention concerning a mold for manufacturing retaining blocks, entitled WALL BLOCK, SYSTEM AND MOLD FOR MAKING THE SAME, for which U.S. Patent Application No. 10/931,485 was filed August 31, 2004.

AND, the Assignors hereby agree to execute any other Assignments which may be required for formally conveying ownership of said applications and Letters Patents to the Assignee;

AND, the Assignors further agree to execute any and all applications for Letters Patents in this country and any foreign countries, and to furnish and deliver to the Assignee, upon request, all data and

documents, and to execute any papers which may be necessary for the prosecution of any application or applications of Letters Patents or for the Assignee to exercise its rights granted hereunder;

The Assignors hereby grant the law firm of Klarquist Sparkman, LLP, the power to insert on this Assignment any further information which may be necessary or desirable in order to comply with all applicable legal requirements, including the rules of the United States Patent and Trademark Office, for submitting and recording this document.



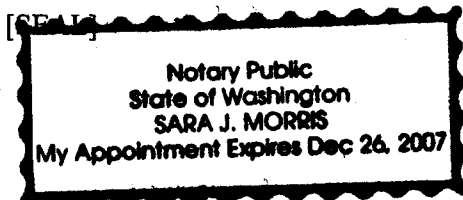


