ASSIGNMENT OF APPLICATION FOR PATENT

Whereas, We **Andrew Longacre, Jr.** and **Robert M. Hussey** citizens of the United States, residing at 21 Leitch Avenue, Skaneateles NY 13152 and 43A Ponderosa Drive, Syracuse NY 13215 respectively, have invented a certain new and useful **Bar Code Reader** for which we have made application for Letters Patent of the United States as fully set forth and described in the specifications prepared and executed by us on January 6, 1995.

And We, for ourselves, our heirs, assigns and legal representatives, hereby covenant to and with said assignee, its assigns, successors and legal representatives, that we have full right to sell and assign the entire interest in and to said invention and the Letters Patent to be had therefor and that the entire interest herein conveyed is free from all prior assignment, grant, mortgage, license or other encumbrance whatsoever.

And We Do Hereby Authorize and Request the Commissioner of Patents to issue said Letters Patent to said **Welch Allyn, Inc.** as the assignee of our entire right and title therein.
