This Confirmatory Assignment ("Assignment") shall be effective as of 12/31, 2005 ("Effective Date") by and between:

ANONYMIZER, INC., a corporation of the State of Delaware, having a principal place of business at 7525 Metropolitan Dr., Suite 306, San Diego, CA 92108, USA ("ANONYMIZER").

1.0 Background

1.1 ASSIGNORS, through their employment with ANONYMIZER, as either employees or contractors, as the case may be, invented certain new and useful improvements as described and set forth in an application for Letters Patent of the PCT Patent Application titled: "SYSTEM FOR PROTECTING IDENTITY IN A NETWORK ENVIRONMENT" Serial No. PCT/US2005/047580, filed December 31, 2005, which claims priority under Section 119(e) to U.S. Provisional Application Serial No. 60/640,924 titled "SYSTEM FOR PROTECTING IDENTITY IN A NETWORK ENVIRONMENT" filed December 31, 2004. 


