## **PATENT ASSIGNMENT**

WHEREAS, Chen-Hung Hung, an individual, residing at No.26, Lane 88, Fuxing Rd., Minxiong Shiang, Chiayi County, Taiwan, has represented that he is the named inventor of United States Patent No. 6,776,657 B1 concerning CONNECTOR CAPABLE OF CONNECTING TO COAXIAL CABLE WITHOUT USING TOOL the invention being described in and identified by an application for United States Letters Patent, filed November 13, 2003, Serial No. 10/705,987, and that he has made no assignment, transfer, or other grant of any right relating to such invention to any person other than EZconn named below;

WHEREAS, EZconn, a corporation, located at No.12.Lane 121.Li-Der Rd, Peito District, Taipei, Taiwan, is desirous of acquiring the entire and exclusive right, title, and interest, together with all rights of priority, in and to said invention in the United States of America, and in and to any Letters Patent which may be granted and issued therefor;

NOW THEREFORE, in consideration of the sum of Ten U.S. Dollars (U.S.\$10.00) in hand paid, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the said Chen-Hung Hung, does hereby confirm in writing his previous agreement and actions to sell, assign, transfer, and set over unto the said EZconn, its successors and assigns, the entire and exclusive right, title and interest, together with all rights of priority, in and to said invention, in the United States, and in and to any Letters Patent which may be granted and issued therefor, and in and to any Letters Patent which may be granted and issued for any division, reissue, extension, continuation, or continuation-in-part thereof, and all rights of action arising from all such Letters Patent, all claims for damages by reason of past and future infringement thereof, and the right to sue and collect damages for any such infringement, the same to be held and enjoyed by EZconn, its successors and assigns to the full ends of the terms of all said Letters Patent therefor which may be granted as the same would have been held by Chen-Hung Hung had this assignment not been made, such assignment having an effective date of at least as early as November 13, 2003. In any case, the parties intend that, for any infringement of the patent and/or invention rights described herein that may have occurred at ANY time, Mr. Hung assigns to EZconn any and all rights to pursue and collect damages for that infringement.

AND CHEN-HUNG HUNG HEREBY COVENANTS AND AGREES that he will execute or procure any further necessary assurance of title to said invention and any Letters Patent which may issue therefor and that Chen-Hung Hung will, at any time, upon the request and at the expense of EZconn, deliver any testimony in any legal proceedings and execute all papers that may be necessary or desirable to perfect the title to said invention or any Letters Patent which may be granted therefor in EZconn, its successors and assigns, and that Chen-Hung Hung will, at any time, upon the request and at the expense of EZconn, execute any division, reissue, extension, continuation, continuation-in-part or any other additional applications for Letters Patent for said invention or any part or parts thereof, all of which applications and any Letters Patent issuing thereon are hereby assigned to EZconn, and will make all rightful oaths, and do all lawful acts requisite for procuring the same therein, without further compensation, but at the expense of EZconn, its successors and assigns.

AND CHEN-HUNG HUNG HEREBY AUTHORIZES AND REQUESTS the Commissioner of Patents and Trademarks to issue any and all Letters Patent of the United States for said invention, resulting from any of the aforesaid applications to said EZconn.
