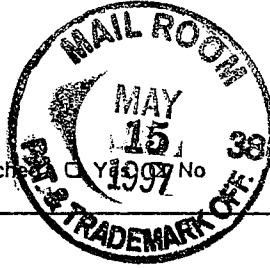

title and interest in, to and under any and all Letters Patent of the United States and foreign countries that may issue or be granted on said invention.

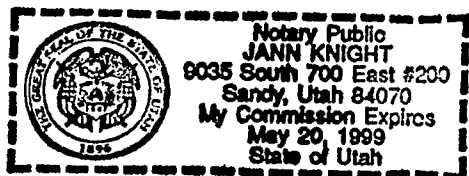

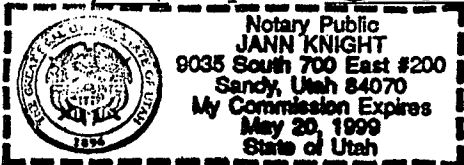

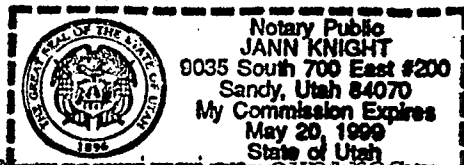
