PATENT ASSIGNMENT

WHEREAS, **Irikura Precious Metal Co. Ltd.**, a Japanese company, having a correspondence address of 22-5 Saiwai-cho, Itabashi-ku, Tokyo, Japan ("Irikura"), is the owner by assignment of all of the right, title, and interest in U.S. Patent Application No. 6,112,551, issued on 5 September 2000, titled "Setting Metallic Parts for Setting a Facet Cut Precious Stone."

IRIKURA HEREBY covenants and agrees that Irikura will at any time, upon the request and at the expense of Rosy Blue, execute and deliver any and all papers and do all lawful acts that may be necessary or desirable to perfect the title to said invention, applications, and patents, and Irikura hereby authorizes the Commissioner of Patents and Trademarks to issue Letters Patent to Rosy Blue.
