And, ASSIGNOR, hereby authorizes and requests the Commissioner of Patents and Trademarks or an equivalent officer in any jurisdiction in which the Assigned Patent may have issued, to issue any and all Letters Patent on said inventions to ASSIGNEE as assignee of the entire interest, and hereby covenants that ASSIGNOR has full right to convey the entire interest herein assigned, and that, except as otherwise provided between the parties, ASSIGNOR has not executed, and will not execute, any agreements in conflict therewith.


