ASSIGNMENT

WHEREAS, Erhard SCHWARTZ, a citizen of Germany, residing at Im Muehlhoelzle 8, 69168 Wiesloch, Germany, hereinafter referred to as ASSIGNOR, is the owner by assignment of certain new and useful improvements in CLOSURE FOR THE POURING SPOUT OF A CONTAINER for which we have filed a design patent application with the U.S. Patent and Trademark Office on August 17, 2007, said application being assigned U.S. Application No. 29/283,600.

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) to me in hand paid, and other good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNOR has sold, assigned, transferred and set over, and by these presents does hereby sell, assign, transfer and set over, unto the ASSIGNEE, its successors, legal representatives and assigns, the entire right, title and interest in, to and under the improvements, and the application and all divisions, renewals and continuations thereof, and all Letters Patent of the United States which may be granted thereon and all reissues and extensions thereof, and all applications for Letters Patent which may hereafter be filed for the improvements in any country or countries foreign to the United States, and all Letters Patent which may be granted for the improvements in any country or countries foreign to the United States and all extensions, renewals and reissues thereof; and we hereby authorize and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for the improvements to ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.



AND ASSIGNOR HEREBY grants to Steven B. Pokotilow, Lawrence Rosenthal, Matthew W. Siegal, Brian M. Rothery, David L. Schaeffer, Ian G. DiBernardo, Charles E. Cantine and Angie M. Hankins, attorneys with the firm of Stroock & Stroock & Lavan LLP, the right and full power of attorney to enter all further identifying information of the improvements and the application as may be deemed necessary or desirable for the recordation or perfection of this ASSIGNMENT.

AND ASSIGNOR HEREBY further covenants and agrees that ASSIGNOR will communicate to ASSIGNEE, its successors, legal representatives and assigns, any facts known to us respecting the improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for the improvements in all countries.
