ASSIGNMENT

WHEREAS, I, PATRICIA URQUIOLA, residing at Via G. Uberti 33, 20133 Milan, Italy, have invented a new original and ornamental design for a FAUCET HANDLE for which I have made application for Letters Patent of the United States of America; and

WHEREAS, HANSGROHE AG, a German corporation, having its office and a principal place of business in the City of Schiltach, Country of Germany, desires to acquire the entire right, title and interest in and to said invention;
