**Howard R. Stuart** of **Glen Ridge** in the County of Essex and State of New Jersey,

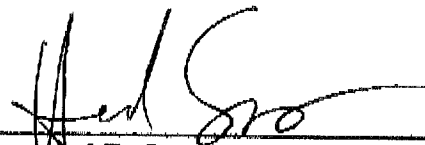

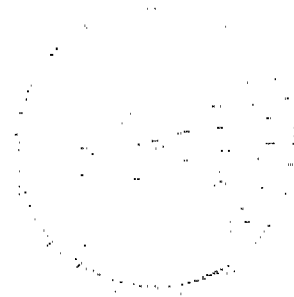
