States) based upon said invention, and in and to the patent or patents to be granted thereon, including reissues thereof, if any, to the full end of the term or terms for which said patent or patents may be granted; and



application or granted patent shall expire upon the first-occurring of (i) assignment to a third party of any of the above-mentioned rights of Assignee, or (ii) with respect to any particular patent, issue of such patent, and shall be subsequently part of the assignable rights of Assignee. All other rights to said invention, said applications and said patents, U.S. or foreign, including the right under any of said patents to manufacture, use, sell or offer for sale the invention covered by said patents, or to license or permit use of said invention, remain with Assignee and shall be assignable by Assignee without the consent of Robert Bosch GmbH.
