- (c) all design right and the right to apply for registered design or similar protection including other intellectual property rights conferred by the law of the United Kingdom and all other countries of the world in the Designs or any part of the Designs and all preliminary workings of the same in all parts of the world, absolutely and in each case for the remainder of the term or, as applicable, for the full term of the same including any renewals, extensions or revivals; and

together with all related rights and powers arising or accrued, including the right to sue for damages and other remedies in respect of any infringement of all these assigned rights prior to the date of this assignment to hold, use, exercise and enjoy the same unto the Assignee; its successors and assigns absolutely on a worldwide basis for the whole period of such rights capable of being assured by the Assignor.

2. WARRANTIES

The Assignor undertakes, at the request and expense of the Assignee, to bring into effect or do all acts and execute all documents which may be necessary to confirm the title of the Assignee to the rights assigned under this assignment, whether in connection with any registration of that title to copyright or design right or other similar right or otherwise.

4. WAIVER OF MORAL RIGHTS

The Assignor being the author of the Designs waives absolutely his right to be identified as the author of the Designs granted by section 77 of the Copyright, Designs and Patents Act 1988 and his right to object to derogatory treatment thereof granted by section 80 of that Act and, so far as is legally possible, any broadly equivalent rights he may have in any territory of the world.

5. GOVERNING LAW AND JURISDICTION

This assignment shall be governed by and construed in accordance with the law of England and the parties agree to submit to the non-exclusive jurisdiction of the English courts as regards any claim or matter arising in relation to this assignment.

6. EFFECTIVE DATE

Both parties agree that the effective dates of the assignment shall be 6th June 2005 in respect of the Piggy Bank and 1st September 2005 for the Drink Bottles.

7. BINDING ON SUCCESSORS

The Assignee may assign, transfer, charge or deal in any other manner with this Assignment or any of its rights under it. 


