ASSIGNMENT

We, Geoff Gosling and Mogens Smed, of 32 Collingwood Place NW, Calgary, Alberta, Canada T2L 0P9; and Box 2, Site 8, RR1, De Winton, Alberta, Canada T0L 0X0, respectively, have invented a method and apparatus entitled **POSITION RETENTION MECHANISM FOR MODULAR WALL ASSEMBLY** hereinafter called the "invention."
