Valent hereby sells, assigns and transfers to Tomen, its successors and assigns, an undivided one-half right, title and interest in each of the '572 provisional application, the '504 provisional application, the '714 patent application, and the '300 application, and the inventions disclosed and claimed therein for the United States of America (but not countries foreign thereto nor rights of foreign priority, such rights already being held by Tomen), with respect to any Letters Patent of the United States of America issuing on any of those applications, or issuing on any subsequently filed United States patent applications which claim the benefit of one or more of those patent applications' filing dates, and Valent requests the Commissioner of Patents to issue any Letters Patent(s) granted upon such invention(s) to Valent and Tomen jointly;

PROVIDED THAT, any such rights being transferred pursuant to this Assignment are subservient to any pre-existing agreements between Valent and Tomen, including the High Strength Orthene Joint Development Agreement executed in 1997.

On behalf of Valent, I hereby aver that I am authorized to act on its behalf, that I have reviewed the prior Assignment executed December 16 and 17, 1997, and that pursuant to that prior Assignment, Valent holds title to the rights being transferred pursuant to this Partial Assignment.
