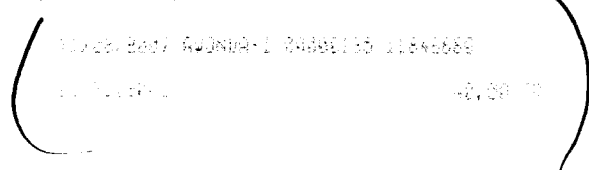

ASSIGNORS specifically agree, upon request of ASSIGNEE, and without further remuneration, to execute any and all papers desired by ASSIGNEE for the filing and granting of foreign applications and the perfecting of title thereto in ASSIGNEE. It is understood and agreed that ASSIGNEE'S attorneys Nixon & Vanderhye P.C. have

represented only ASSIGNEE and will continue to represent only ASSIGNEE with respect to this invention:






