U.S. PATENT ASSIGNMENT

This assignment is subject in all respects to the terms and conditions of the Agreement and is intended only to document the assignment of the Assigned Patents. Nothing contained in this assignment shall be deemed to supersede any of the obligations, agreements, representations, covenants, or warranties of Company and Rembrandt contained in the Agreement.
