ASSIGNMENT

AND, for the consideration aforesaid, I do hereby agree that my executors and legal representatives will make, execute and deliver any and all other instruments in writing including any other documents, and will communicate to said SciMed Life Systems, Inc., its successors and representatives all facts known to me relating to said improvements and the history thereof and will testify in all legal proceedings and generally do all things which may be necessary or desirable to more effectually secure to and vest in SciMed Life Systems, Inc., its successors or assigns the entire right, title and interest in and to the said improvements, inventions, applications, Letters Patent, rights, titles, benefits, privileges and advantages hereby sold, assigned and conveyed, or intended so to be.

AND, furthermore, I, Timothy J. Mickley, covenant and agree with said SciMed Life Systems, Inc., its successors and assigns, that no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been made to others by me and that full right to convey the same as herein expressed is possessed by me.

The parties hereto acknowledge that he has specifically requested the present agreement to be drawn up in the English language.
