And we hereby authorize and request the Commissioner of Patents and Trademarks and other authorities in foreign countries to issue any and all patents on said Inventions or resulting from said Application and from any and all regular and other patent applications, divisions, continuations, continuations-in-part, and reissues thereof or claiming priority thereto, to **SOLYNDRA, INC.**, as assignee of our entire interest, and hereby covenant that we have the full right to convey the entire interest herein assigned, and that we have not executed and will not execute any agreement in conflict herewith.



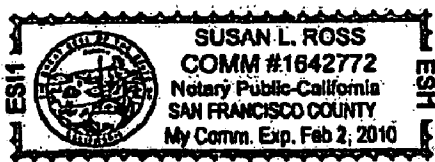

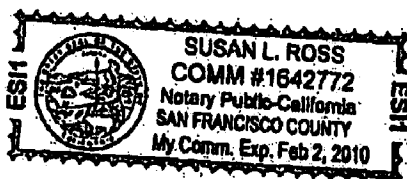
