For the sum of One Dollar and other valuable consideration to us in hand paid, receipt of which is hereby acknowledged, be it known that I,


1. James Tadashi Masamoto, a citizen of the United States of America, having a place of residence at 4773 Gateshead Road, Carlsbad, California 92010;
