#### PARTIES

- (1) GKN AEROSPACE TRANSPARENCY SYSTEMS (KINGS NORTON) LIMITED incorporated and registered in ENGLAND with company number 01999018 whose registered office is at Ferry Road, East Cowes, Isle Of Wight PO32 6RA (Assignor).
- (2) GKN AEROSPACE SERVICES LIMITED incorporated and registered in ENGLAND with company number 00355922 whose registered office is at Ferry Road, East Cowes, Isle Of Wight PO32 6RA (Assignee).

#### BACKGROUND

- (A) The Assignor is the proprietor of (or applicant for) the patents and patent applications listed in Schedule 1 to this assignment (Patent(s)), the trade marks listed in Schedule 2 to this assignment (Trade Mark(s)) and the owner of other unregistered intellectual property rights.
- (B) By an agreement dated 20 December 2006 between the Assignor and the Assignee for the sale by the Assignor and purchase by the Assignee of the business of the Assignor (the "Sale Agreement"), the Assignor has agreed to assign the Intellectual Property (as defined therein), which includes without limitation the Patent(s) and the Trade Marks (as defined herein) to the Assignee on the terms set out in this assignment.

#### AGREED TERMS

##### 1. DEFINITIONS

The definition in this clause applies in this agreement.

**Unregistered Intellectual Property Rights:** all Intellectual Property (as defined in the Sale Agreement) other than the Patents and the Trade Marks, including without limitation rights to inventions, copyright and related rights, rights in designs, rights in computer software, database rights, rights in confidential information (including know-how and trade secrets) including all rights to apply for Patents, Registered Designs and all similar or equivalent rights or forms of protection which subsist or will subsist, now or in the future, in any part of the world

## 2. ASSIGNMENT

In consideration of the sum of £1 (receipt of which the Assignor expressly acknowledges), the Assignor hereby assigns to the Assignee with full title guarantee:

2.1 the full and exclusive benefit of the Patents including, without limitation:

(a) the right to recover and take all such proceedings as may be necessary for the recovery of damages or otherwise in respect of any and all infringements of any of the Patent(s), whether committed before or after the date of this agreement;

(b) the absolute entitlement to any patent(s) granted pursuant to any of the application(s) comprised in the Patent(s), for the full term of such patent(s); and

(c) the right to apply for, prosecute and obtain patent or similar protection in the UK and all other countries of the world for an invention embodied by any of the application(s) comprised in the Patent(s), including the right to claim priority from such application(s).

2.2 all and any rights in and to the Trade Marks including without limitation:

(a) the right to recover and take all such proceedings as may be necessary for the recovery of damages or otherwise in respect of any and all infringements of any of the Trade Marks or for passing off or otherwise in relation to the Trade Marks, whether the infringement(s) or other act(s) (as appropriate) was (were) committed before or after the date of this agreement; and

(b) any and all statutory and common law rights and all goodwill attaching to the Trade Marks.

2.3 all Unregistered Intellectual Property Rights owned by the Assignee at the date of this agreement, including the right to sue for damages and other remedies for infringement of any of such Unregistered Intellectual Property Rights which occurred prior to the date of this assignment.

## 3. FURTHER ASSURANCE

The Assignor hereby covenants with the Assignee that the Assignor shall, at the expense of the Assignee, execute, sign and do all such instruments, applications, documents, acts and things as may reasonably be required by the Assignee to

enable the Assignee or its nominee to enjoy the full benefit of the rights assigned by this agreement.

4. **GOVERNING LAW AND JURISDICTION**

This assignment shall be governed by and construed in accordance with the law of England and the parties hereby submit to the exclusive jurisdiction of the English courts.

5. **ENTIRE AGREEMENT**

This agreement and the schedules to it shall constitute the entire agreement and understanding between the parties with respect to all matters which are referred to herein and shall supersede any previous agreement between the parties in relation to such matters.

6. **EFFECTIVE DATE**

This agreement has been entered into on the date stated at the beginning of it but shall be deemed to have commenced upon 30 June 2006.




