
right to convey the entire interest herein assigned, and that, except as otherwise provided between the parties, COMPANY has not executed, and will not execute, any agreements in conflict therewith.

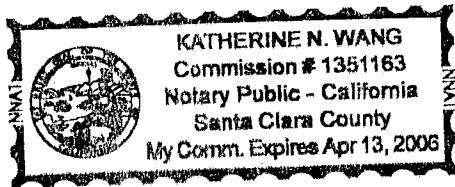
